Registration for subsequent vehicles will be charged to your account as follows: 2nd Vehicle - \$50.00 refundable deposit 3rd Vehicle - \$54.50 w/GST per month Member must display the car park label for entry to the Club. Only vehicles with valid car park labels are allowed to park at the designated members' car park lots. Members found not displaying the car park labels may be refused entry or be directed to park their vehicles in the visitors' parking lots (as per Bye-Laws Clause 10c) Please note that if your vehicle number has been changed (e.g. sold your vehicle or using a different vehicle to enter the Club), you are required to return your old car park label in exchange for a new label, at our Main Reception counter, open daily from 9am – 10pm It will take 1 working day upon receipt of this application form and all the required documents for change of IU number to take effect It will take 1 working day upon receipt of this application form and all the required documents to de-register
