  - shall not be eligible to hold office or vote at general meetings;
  - o shall not be eligible to subsequently transfer or sell his membership including transfer upon death;
  - shall maintain a refundable credit deposit of \$500 and be subject to a spending limit of \$1000;
  - o shall be able to enjoy all the facilities of the Club
