

## Information for Prospective Members

### Becoming a Member

#### What do I need to bring with me when I apply for my membership?

- A completed application form
- Payment via cash, cheque or credit card. (All cheques must be crossed and made payable to “SGCC” or “Serangoon Gardens Country Club”)
- The following documents:
  - a) Copy of applicant’s identity card
  - b) 1 recent passport-sized photograph of applicant
  - c) Copy of spouse’s identity card (where applicable)
  - d) 1 recent passport-sized photograph of spouse (where applicable)
  - e) Copy of marriage certificate (where applicable)
  - f) Copy of birth certificate of all children below the age of 21 (where applicable)
  - g) 1 recent passport-sized photograph of each child below the age of 21 (where applicable)
  - h) Copy of car log card to prove ownership of vehicle (for car park label)
  - i) Duly completed GIRO form (required for installment scheme)

#### How long does it take to process my membership application?

All applications are subject to the approval of the Club’s General Committee. Once we receive all necessary documents along with your application form, we aim to process your application within 2-3 weeks.

#### Can I pay by instalments?

Yes. We are currently offering attractive interest-free instalment schemes for purchase of Ordinary / Corporate Memberships. Please refer to our “Becoming A Member” page for more information.

#### Can I use the Club’s facilities immediately after I sign up?

No. Your application must first be approved by the General Committee. After your application has been approved and processed (this usually takes about 2-3 weeks upon receiving your application), we will notify you. You may then collect your membership card from the Main Reception and start using the Club’s facilities.

#### Can my whole family enjoy the Club’s facilities when I sign up as a member?

Yes. For members with family, the monthly subscription fee for an Ordinary (\$90.95) or Term (\$101.65) family membership covers their spouse and children under the age of 21. The family membership subscription does not cover children above the age of 21, nieces, nephews or any other relatives.

However, if you are an Ordinary Member, when your child turns 21, you will have the option of applying for a Supplementary Membership so that your child can continue to enjoy the Club’s facilities.

**Do I have to pay to use the Club's facilities?**

Yes. To use most of the facilities, members will have to pay a nominal fee. However, the swimming pool and gym are free of charge for members. For facilities rates and charges, please refer to the "Facilities" page on our website.

**Does the land belong to the Club?**

Yes, the land the Club sits on belongs to the Club.

**Do members have to pay for upgrading and renovation costs?**

So far, members have not been approached to pay for such costs. Through prudent financial management over the years, the Club has accumulated sufficient surplus funds to pay for such expenses.

**Do all members have voting rights?**

Only Ordinary Members and one nominee from each Corporate Membership have voting rights.
